Your complaint will be reviewed in accordance with the Maine Rules for Guardians ad Litem adopted by the Maine Supreme Judicial Court effective September 1, 2015. Please be aware that a copy of this complaint and any attachments will be provided to the guardian ad litem.

If you require assistance completing this form, please contact the Board's Central Intake Office at (207) 623-1121. Normal business hours are from 8:00 a.m. to 4:30 p.m., Monday through Friday. You may also submit any questions about completing this form via email.

Upon receipt of your complaint, Board Counsel will review your complaint to determine whether the facts stated provide grounds for further action by the Board. The process for reviewing and processing GAL complaints is outlined in Rule 9 of the Maine Rules for Guardians ad Litem.
